You must agree to work with Cartus (Caterpillar's Relocation Provider)



The home you are selling must be within 20 miles of: 100 NE Adams Street, Peoria, IL 61629

Compliance with program procedures including, but not limited to:

- ✓ Privacy Consent, via CartusOnline system
- ✓ Signing of Cartus Homeowners Real Estate Disclosure
- ✓ Signing of Cartus Statement of Loan Information in order for Cartus to gather pertinent information to fund your equity
- ✓ Signing of Contract of Sale with Cartus as buyer of your home
- ✓ Clear Title and Deed on your property
- ✓ Clearance on inspection(s) and other requested repairs to your property
- ✓ Signing of Equity Disbursement Form

Note: Cartus will fund your equity based on the offer price, withholding mortgage interest, taxes and HOA dues if applicable.
