- ❶ A properly completed REALTOR® Membership Application.
- ❷ A copy of your Real Estate License or 45 Day Permit Sponsor Card.
- ❸ Payment which will include the initial fee, prorated dues and MLS fees.  
(We accept payment in the form of a personal check, cash, VISA, MasterCard or Discover.)
