## QUALIFICATIONS

### REALTOR® OF THE YEAR

#### **Local REALTOR® Member Association Activity**

- such as committee work (including chairing a committee or task force), serving on Board of Directors, meeting attendance, seminar and educational achievements, or any local Association sponsored activity.

**Professional Ethics & Practice** - faithfulness to principles of organized real estate, laws and regulations of the Association, Code of Ethics, efforts to encourage good real estate practice among other real estate brokers.

**State Association Activity** - such as committee assignments held or special assignments completed, attendance at state convention, quarterly meetings, legislative assemblies, seminars, visits to other Associations, institutes and any state sponsored activity.

**Other REALTOR® Activities** - NAR committee assignments, NAR conventions, institutes, etc.

**Education & Designations** - educational achievements and designations of importance in the real estate profession.

#### **Business Accomplishments/Achievements & Contributions**

- the criterion here is not the number of dollars earned, but the public recognition gained from the manner in which he/she conducts their business, outstanding advertising programs, a general reputation for professional competence, etc. Can include individual selling success.

Note: The REALTOR® of the Year criteria is based on activities from not only the current or past year, but from previous years as well.

### AFFILIATE OF THE YEAR

- Affiliate Member Enthusiasm.
- PAAR Activities/Committee Involvement.
- Civic Activities.
- Business Accomplishments.
- Other Activities.

### ROOKIE OF THE YEAR

- This award is based primarily on sales production.
- Sales production of a minimum of 1 million or more, in a qualifying year.
- REALTOR® members qualify for either of the first 2 full calendar years of membership only.
- Shows sincere interest/enthusiasm in profession and PAAR.
- Teams with licensed assistants do not qualify, must be an individual. (Individual award)
- Nominated by DR/Manager.
- Other community activities.

### INDUSTRY ACHIEVEMENT

- Recognized as having made outstanding contributions to the Peoria area real estate industry and the promotion of private property rights.
- Been instrumental in the advancement of real estate through such efforts as residential and/or commercial development.
- Served as a role model for other real estate professionals.

### DISTINGUISHED MEMBER FOR COMMUNITY SERVICE

- Is in good standing with the PAAR, the Illinois Association and the National Association of REALTORS®.
- Holds an active real estate license; is active in the real estate industry.
- Recognized as a local leader whose performance of service and involvement in community activities is extraordinary.
